NOTICE IS FURTHER GIVEN that all property owners having any objections to the proposed removal of such weeds from the aforementioned properties are hereby notified to attend a public hearing of the Redlands City Council to be held on **February 4, 2025 at 6:00 p.m. in the Redlands City Council Chambers of Redlands City Hall, located at 35 Cajon Street, Ste. 2, Redlands, California 92373** when and where objections will be heard and given due consideration.
